



PRIVACY POLICY

GREEN RIO TEC LTDA ME, considering the importance of protecting privacy, sets out below its policy for the treatment of personal information of users of the I Summit Climate Change and Wildland Fires website

The information collected only from browsing the website pages, not involving interaction with electronic forms, generates an access log that stores information that, however, does not allow the visitor's personal identification. Such information basically serves to generate general statistics and analysis on the use of the website.

Personal information, on the other hand, is that which is voluntarily collected by filling out our registration forms, which you are not required to fill in to navigate through the website's pages. GREEN RIO TEC undertakes not to disclose the personal data of any user, without his prior authorization, keeping them under strict confidentiality. For your security, an email will be sent to the registered email address to verify the information and confirm the signature. Cookies are information files transferred from a website to the user's computer, recording their browsing and consumption habits. The user, if interested, can configure the browser on his computer to be notified of the receipt of referrals.

Any change to the Privacy Policy will be duly announced on the website's main page, within a minimum period of 15 days prior to the implementation of the changes present in the Policy.
